


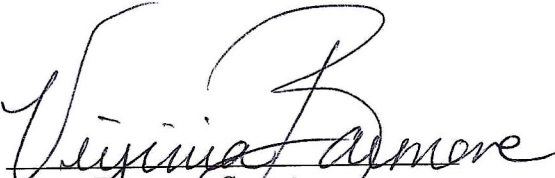
MINUTES OF BOARD MEETING
